# MINUTES OF THE REGULAR MEETING

# OF THE LA SALLE CITY COUNCIL

## March 18, 2024

A regular meeting of the La Salle City Council of La Salle, Illinois was held, Monday, March 18, 2024, at 6:30 p.m. with Mayor Jeff Grove with proper notices being duly and continuously posted.

The meeting was called to order at 6:30 p.m.

## PLEDGE OF ALLEGIANCE

Alderman Herndon joined the meeting remotely.

A quorum was present.

#### **COMMENTS**

Mayor Grove reminded the public that during the public comment portion of the meeting to state your name for the record when coming up to the podium. He also asked that everyone receives their uninterrupted five minutes during their public comment portion.

Mayor Grove asked Alderman Herndon to mute himself on his side or to move his dog to another room, so the barking doesn't interrupt the public's comment time.

Dawn Hicks stated that she is apparently not allowed to ask questions about the city's water or air monitors. She said that she has recently had conversations with her husband about the conversations that he has had with John Duncan. She stated that Duncan asked her husband why Dawn keeps coming to these meetings and that she is "apparently a bored housewife who just likes drama". She wanted to make it clear with the public and the council that she does "give a crap about this town. She said that she has raised all four of her children in this town and she genuinely wants the best for this town. She said she didn't appreciate the conversation between her husband and Duncan. She said that it has been a year since Carus' fire and they have not asked and have been patient but she would like to know what the plan is when Carus "blows up again". She asked if anyone had an answer. She asked if the city is still not safe. She said that it was really disheartening. She said she is naive and didn't realize that Carus ran this town. She stated that it would be nice to have some idea for the next time something like the Carus fire occurs, to keep our families and pets safe. She also pointed out that it is not interrupting when Mayor Grove was calling on someone after raising their hand and following all the rules. She asked City Clerk Amy Quinn to be a little more diligent about the accuracy of her reports because she was not interrupting when the Mayor called on her.

Jamie Hicks, Fourth Ward resident, said that he will continue where Dawn had left off. He stated that the city is still at the same point where Carus is free to do whatever they wish, as long as their contaminants do not get on the city streets or the toxic material in the air doesn't land on city property. He said the same thing that Dawn mentioned about no plan and that the city is still standing where they were over a year ago. Hicks wants to know why and how much money this city actually makes from Carus Chemical. He states that the city has made many attempts of shutting him up with all the drama with Mike Smudzinski. He claims that these are all done by Mayor Grove because they are all hired and fired by him. Hicks states that it is plain to see the mayor's retaliation and the extremist measures that he will try to do to silence Hicks. Hicks states that they have only ever wanted transparency from the City. Hicks stated that a long time ago, he did ask the Mayor and all the councilman, how the city can move forward from this? Hicks says that he never did get an answer. He continued with a discussion in regard to a public hearing on a park grant. He asked when the council knew about this hearing and when it was posted and where it was posted. If he is unable to get an answer to this question, he will put a FOIA in for that. Hicks also mentioned a 2024 road project. He asked when is there a road project that the city never mentioned. He also where are these private meetings where the city is negotiating who gets a road and who doesn't get a road. Hicks said that the whole point of the city meetings is to be transparent. Hicks does not believe it to be fair that the mayor is in charge of the police chief, the fire chief and the finance guy and anyone else who sits in the front row. He wanted to mention the minutes. He stated that it read that he interrupted 15 times but it was one interruption. He said that

Chief Smudzinski almost told the truth in his police report. Hicks stated that it is a crime for lying in a police report. Hicks also asked who the city has to replace him when Smudzinski retires. Hicks asked if it was "another asshole".

Hicks continued by stating that ordinances are supposed to be enforced equally and fairly. Hicks does not believe that they are enforced equally or fairly in this room. He stated that Mr. Duncan made a comment about shutting time off when people are talking, and he does that now but Hicks can show a ton of videos that shows that he doesn't do that to him. Hicks said that this is a violation of the Open Meetings Act. Hicks continued by stating that he has been denied ordinances and was told he had to wait because of a FOIA request. He said that this is a violation of the Open Meetings Act because he did not put in a FOIA request. He asked if the council needed to be retrained in the Open Meetings Act because he said that is what it feels like he is doing up here. He said that the city keeps violating his rights and it will catch up to everyone. He told Duncan that he can "stare at me all you want, Johnny. I don't care. Mr. Golden spoon. My time is up sir."

Shawna Wilcox, LaSalle resident, stated that she came to her first city council meeting earlier this month with the intention of asking questions and airing grievances over some water billing issues and the third-party payment services network. She said she was surprised to see citizens fighting for drinkable water and police accountability while being ignored entirely. She said that she didn't speak that night and went home to gather some facts so she would be able to get the best result. She said that the council was "bad leadership verging on fascism". She continued by stating that the city does not want people to know what's in their water and that it's unsafe. She said that the city is hiding the truth and the result is much worse with more illness and disability, which leads to more poverty. She said that the citizens are not asking much, just that their tax dollars pay for safe water. She mentioned the letters that the residents get in the mail in regard to the water that has trihalomethanes in it, but the city says not to worry because it is not a concentration that the citizens should worry about. She stated that when she looked through previous meeting minutes it seemed to be the same issues every single week. She said that they were the same issues that she has repeatedly questioned and got no answers for. Wilcox said that the residents have to get a science degree and a DIY test to figure out if their water is safe because the water companies won't help them. She said that she has seen permanent damage from this. Both her and her son have autism and everyone she knows has some kind of neurological disorder or hormone disruption. She stated how hospitals and grocery stores are closing and buildings are abandoned. She mentioned that the police budget is \$4 million and most of it is paid out in lawsuits. She asked the council "who do you work for and how do I get you to work for me?"

Julie Malamassari spoke next in regard to her concern for the men's league diamond and the safety of the players on the little league diamond. She said that when the men's league does play, they can hit balls to or near the little league fields. She would like to see these not playing on the nights that the kids are not there. She feels that it is really

dangerous. She stated how it is not just the kids on the field that are in danger, but it is also unsafe for the bystanders at the park too. She stated how there was an instance when the other team actually left the game because they did not feel safe on that side of the field. She said that there was also an umpire that came and spoke at their board meeting. He stated to their board that he will no longer be umpiring on nights when the leagues are playing because it's a danger to the kids and the parents.

Josh Busche, LaSalle Baseball President, continued with the same concern. He stated that he is dealing with umpires that will not umpire on league nights, along with coaches who are discussing this also. He stated that M&H is now open and available to anyone because the Senior League and Junior league are now going to be playing out at Rotary. He is concerned with the Home Run Derby that is going on in the men's league on that field near the little league diamond. He said that he was told that the men's league has umpires who are checking the balls and bats. He is not believing that and he said that they are getting anyone to umpire and are not sanctioned to even umpire. He is concerned also because there was damage to the field at one point, they went to Ottawa and Oglesby to play but were both booted from those towns and are back to play here in LaSalle. He said he watched a ball almost hit center field on the fly last fall. He is concerned with the kids' safety. He mentioned that he looked up exit velocity' on bats. He said that the ball could possibly have been going 100 mph when it was hit to center field last season. He is asking that the men's league gets moved to M&H so there are no fields in the way, or fans or players. He said the main reason that he believes that they do not want to be at M&H is because right field is a 227ft fence and they are potentially losing many of their balls in the Carus property. He said the women's league was willing to move out, why are not the men willing to. He is hoping that someone would be able to talk the men's league.

Angel Farmer was next to speak and she asked for everyone to lift their heads and listen. She started out by stating that John Duncan had seemed like an intelligent, fairly pleasant man from her few encounters with him. She said that she has, however, uncovered some issues. She began with the hearing on February 29 at the downtown Ottawa courthouse. She was disappointed in Duncan, as he made false allegations in an attempt to have Mr. Hicks arrested on felony charges. She stated that Deputy Arthur investigated the incident by speaking with Duncan and later speaking to Mr. Hicks at his home. According to his report, which was made after the hearing, Duncan claimed that in the courtroom, prior to the start of the hearing, that Duncan was threatened by Mr. Hicks. She said that Duncan specifically stated that Hicks had said to him, "He hoped he didn't see you outside because he'd kicked your ass." She said that few others made similar statements. She said that Brent Bader told deputies that Jamie said that "he hopes he doesn't catch John outside". Deputy Pastrick, who is watching over the courtroom during the hearing, reported he witnessed no issues with Mr. Hicks' behavior. He also reported he heard Duncan telling Deputy Arthur that you only wanted the incident documented. She continued by stating that the next day, March 1, Deputy Arthur reported that he received

a message to call Duncan and he did so. He stated that you asked if the report was finished for Jamie "threatening to whip the fuck out of you" and she reported that Duncan asked Deputy Arthur what was going to be done about the incident. She said the Duncan reported to Arthur that again that Jamie had "threatened to whip the fuck out of you" and that Duncan now wanted to press felony charges. She said that the report states that Duncan was notified that this claim is entirely different than what he had first reported to Deputy Arthur. She reminded Duncan of his original report that stated that Jamie "threatened to kick your ass outside". Farmer stated that she was shocked that a honest deputy handled this investigation, since it was the same sheriff's office that had her kidnapped three years ago. She said that the attacks on Mr. Hicks are so outrageous that the "crooked" State's Attorney has not even taken up any of the recent allegations made. She commended the deputies involved for doing the right thing and for doing their job honestly. These are people's real lives. She said that John, the Mayor, and Brent are "messing with people's real lives". She said that it is illegal and wrong to use their positions, tax dollars and sworn officers to attack the people who challenge their behaviors. She also said that Mr. Duncan told the deputy that Jamie was upset claiming Duncan was talking behind his back. Duncan said that he did not do that but Farmer claimed that Duncan was telling her that on her audio recording. She told Duncan that filing false police report and switching from your original story is dangerous for everyone involved. She told Mr. Grove that he is doing the citizens and the city employees a huge disservice by participating in and encouraging these behaviors. She said that she had explained to them what happened with her in the sheriff's office, turning in corruption, has cost her 1000s of dollars, six weekends in jail, and being abused in handcuffs. Farmer said that her case is in the middle of the appeals process, and she is no longer paying for it. She stated that both the defense and the prosecution are now being covered by the taxpayers, with many of those taxpayers being residents of this city. She said that "you can't count on people being scared into a plea deal if you maliciously or wrongfully arrest them". She mentioned that she was offered a plea deal but she knew she couldn't. She said that over these three years the taxpayers have fronted 10s of 1000s of dollars due to her misdemeanor charges. She said that the Supreme Court moved her appeal to a new district in the interest of justice. Some of us do stand up no matter how hard that may be. She stated that abusing the power one has and going far beyond the scope of one's authority will be more devastating for our future generations. She said that she appreciated those who had enough decency to look up and listen to her comments. Farmer said that for the remainder of her time, she will take a moment of silence for anyone abused, targeted, falsely arrested, and maliciously prosecuted, or murdered by the government.

Finance Director informed Ms. Farmer when her five minutes were up.

Mayor Grove mentioned that RJ was very active with LPAC functions and he wishes her the best.

Deputy Clerk Brent Bader mentioned that he knew that the following request was not a fundamental change to the traffic, but he felt it would be most appropriate to be forward to Streets, Alleys, and Traffic committee to review. This may allow for a few neighbors to attend to share their experiences in regard to this matter.

Moved by Alderman Bacidore and seconded by Alderman Lavieri to send the request from David Washkowiak of 9 Seventh Street to Streets, Alleys, and Traffic Committee regarding adding a "Slow Children Playing" Sign on Seventh Street between Chartres and Peru Streets.

#### **OLD BUSINESS**

Moved by Alderman Lavieri and seconded by Alderman Reynolds to allow Chris Perra of TEST, Inc. to present to the city council regarding lead/copper water sampling results.

# Voice vote, all ayes. Motion carried.

Perra reviewed his findings with the council and shared a document outlining all the different levels of copper and lead testing from the past few years. Perra said he's just become the City's water operator and familiarized himself with the situation quickly. He said the City's usually conducts lead and copper testing every three years. In 2016 had 20 samples collected with one with an elevated level. An elevated level is one that is above the EPA set limit for concentration. In 2019, no samples came back high. In 2023, two of them were elevated. Nothing at that time required additional sampling or testing. In 2023 5 of 40 samples were above the level and additional testing was done where 6 of 47 samples were elevated. This recent quarter of testing only one was elevated of 36 samples that have returned. Four more samples have yet to be received.

Perra said lead and copper testing is done at people's homes and they are usualy the most severe tier types as for having lead such as older homes and parts of town. He said the City has to rely on the homeowner to test which includes flushing the line and have it sit overnight then first draw from that tap. He said over 30 years of experience, he regularly sees these ups and downs. He said it's not always the homeowner's fault, and sometimes they may switch up the faucet they use. From 2016 to current, he said like any town you see ups and downs. He said it is not indicative of the entire town. He said going forward they will be making sure homeowners get more training to ensure its being conducted correctly. The lead line service inventory is something else the City is

doing for the future. Perra said lead or any type of metal coming from the hosue plumbing that is sitting there, the best way to avoid it is to let it run till it gets cold. He said it concentrates overnight when no one has been using it, which is why it is tested for in that way. This is mainly for drinking or cooking as residents wont typically be ingesting it when showering. He said anyone who had been tested had received their own unique result and if they were above or below and how to minimize their exposure to lead. He said this is happening everywhere and what makes it unique is that the testing last year lead to a notification to the full public, even if it may not affect every resident.

Mayor Grove asked if it was because the City didn't share their results as promptly. Perra said it's not just that, he said we had a couple of high results and this will continue until the testing drops down. Grove asked if he sees this elsewhere and how many communities he works with. He said he works with roughly 150-200 communities and he's seen this with all of them. He said older towns have older homes with older plumbing. He said if people are concerned, they can have their water tested. Alderman Thompson asked when the next sampling would be. Perra said we're on quarterly testing. He said in the past it wasn't quarterly and used to be every six months. He detailed the previous testing process. Mayor Grove said the City previously tested pool water following the Carus Chemical fire with TEST, Inc. Grove told Perra that if any residents want their water tested as it relates to this, that he can bill the City for that testing. Grove said he didn't want any resident to fear having to pay to have their water tested. Perra said he would do that. Perra answered additional questions about what he presented previously, specifically confirming that these tests were site-specific and are sites where lead and copper is most likely to be found. He also gave information about how homeowners can test their own service lines to determine if they are copper or lead. He also answered how different faucets in a home can provide different results where one room could present a much different test than one conducted in another room despite being in the same home or building. He said switching out a faucet could also result in a lower test later. Alderman Crane reiterated that residents could contact TEST. Inc. To have their water tested but would they also be able to answer questions if residents have any questions. Crane referenced a resident who spoke earlier about water issues. Perra said he'll answer any questions residents may have. Duncan noted that Perra's number was included on an informational packet that was sent out to every La Salle resident.

Alderman Jeppson questioned the issue between the little league and the men's league. He wondered if there would be an issue, why not use M&H. Mayor Grove thought he gave the alderman an explanation of this. Alderman Thompson said that he used to watch many baseball and softball games. He does not remember a ball ever going into the little league diamond. Alderman Jeppson does not recall this ever occurring either. Alderman Lavieri mentioned a net being up in right field. Mayor Grove mentioned that road at M&H right field is their road, and the city is unable to move that road if they wanted. Mayor Grove mentioned that he has met with Linda and the boards, and he

passed this information on to the alderman. Mayor questions if the city should not have boards since this information and concerns seem to be going right to the alderman and not to the boards.

This was the first time that Mayor has heard about the coaches and the umpires having concerns with the men's league playing at Hegeler. Alderman Thompson mentioned that they do make nets big enough and tall enough to possibly solve this concern. Mayor Grove said that he would like a recap from each night this year. He also would like to follow up with other teams and umpires that mentioned not wanting to come back to LaSalle to play. Men's League mentioned that they would not start till June 1, with games two days a week, Tuesdays and Thursdays. He mentioned there will probably only be a two-week overlap with little league.

Alderman Crane asked Mayor to follow up with a few people and discuss again at the next council meeting.

Deputy Clerk Bader mentioned the E-Recycling Event registration will be going live tomorrow. The event will be April 6<sup>th</sup>. The registration page is lasallerecycling.as.me. This is the same URL that was used two years ago. One can email to set up a drop off time at <a href="mailto:service@a-teamrecyclers.com">service@a-teamrecyclers.com</a>. One can also call 815-630-4308 between 8 and 4 Monday through Friday to set up an appointment. Bader shared the webpage in regard to what is expected at this event. The LaSalle event is April 6 for LaSalle residents only but there is also one April 20 at LaSalle County. For the April 6<sup>th</sup> event there are 15 min. Increment times for drop offs from 8am-12pm. Bader shared from the website the items that are and are not accepted for this event. There is a 2 TV limit per vehicle. Bader plans to share this event on the city's Facebook and website also. Bader stated that the city disposed of approx. 32,000 lbs. of E-waste two years ago.

Mayor Grove wanted to recognize Chief Kramarsic in the audience. Mayor Grove also mentioned that yard waste disposal is also open now, it opened March 1<sup>st</sup>. The hours for drop-off are 8am-4pm Saturday and Sunday, 730am-230pm Mon-Tues., Thurs-Fri., and then Wednesday 730am-6pm. He also said that there is a dumpster for just yard bags at the new Public Works Building on St. Vincent's. Bags can be disposed of anytime till 230pm Mon-Friday. Mayor Grove said that starting April 1, tree branch pickup will be back on a schedule. Residents can call to get their names on a list for branch pickup.

Mayor Grove mentioned that there is a group going around in town to check to see where lead lines may be. One may notice a hole in their yard for a short period of time. The city guys will be around to fill any of those holes that are made due to this testing.

Mayor Grove asked Andy Bacidore to speak in regard to an update at 801 First St. Andy Bacidore and Alderman Ptak took a walk through 801 1<sup>st</sup> St. last week with the current project manager to this particular piece of property. He stated they have been in there three or four times in the last two or three months. He mentioned that the rough-in is done in the upstairs, plumbing, electrical, HVAC and is framed up. The plumbing is

done in the downstairs other than the concrete floor. The project manager did show them the improvements that were done on the structural integrity of the building. The project manager did say that they were told to now switch to the outside of the building. Bacidore did speak with other contractors that were lined up to do work there. Bacidore does believe that there are things moving along there. He mentioned that he asked if the upstairs drywall and finished could be done by April 30 and the contractor did not think it to be a problem.

Mayor Grove did state that the city's agreement with this property was April 30 to have the upstairs done to be rented out for livable space.

Mayor Grove thanked everyone that participated in the St. Patrick's Day parade. He also mentioned that this upcoming Saturday at 11am there will be an easter egg hunt at 11am.

Mayor Grove wanted to recognize the TCA 7<sup>th</sup> and 8<sup>th</sup> Grade girls for both finishing 3<sup>rd</sup> place at State in volleyball.

#### **NEW BUSINESS**

City Engineer Brian Brown mentioned the Grand Opening of the Disc Golf Course tomorrow at Rotary Park at 2pm. There will be a ribbon cutting and the volunteers will be out there that put countless hours into the course to get it to fruition. Fire Chief Janick mentioned that he ran into some gentlemen from Chicago who drove down just to challenge themselves at this course and it did challenge them. Brown also mentioned that one volunteer spends many hours out there playing and he has mentioned that the course has been visited by many people from Chicago, Bloomington, Peoria, and Rockford.

Alderman Lavieri mentioned that the members of the Rotary Club went out to seed the 10 acres of the pollinator garden. They did not have the proper spreader at the time and had to go back out again to complete the work.

City Engineer Brian Brown mentioned that this would be utilizing MFT and the city would have to pass a resolution for those funds. Brown also mentioned that two years ago the city had to do a resolution every year for the bonding but that is now gone. This gives the city more money every year to give toward the roadways. He believes that this year it's \$390,000 and they have a little more on that but he wanted to reserve some for the funds that the city will need on Richard Hallett and Eighth Street and the city will be required to pay 20% of those costs.
